GENERAL TERMS & CONDITIONS

The Tender shall be submitted in accordance with these instructions and any tender not confirming the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

1. The Bid provided on emailed must contain the scanned copy of EMD and all other requisite documents called for in the tender.
2. **No conditional bid will be accepted.** The EMD will be refunded to the unsuccessful bidders as soon as practicable after a final decision has been taken on the Tender and to the successful bidders after furnishing the required Security Deposit for the contract.
3. **The intending Tenderer, in case of Prime Manufacturers of drip materials shall upload a self-declaration on their letter-head as PDF file in email of the tender, along with the tender documents, confirming that they are regular in manufacturing and supplying of similar materials/items.**
4. **The intending Tenderer, in case of Authorized Distributor/Dealer/Agent shall possess valid authorized Distributorship/Dealership license from Original Manufacturers. The bidder shall upload the copy of the same as PDF file in email of the tender while submitting the tender.**
5. The Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF formats. Bid documents may be scanned with 100 dpi with black and white option.
6. **THE MATERIAL SHALL BE IN COMPLIANCE TO THE REQUIREMENTS & SPECIFICATIONS MENTIONED IN THE ANNEXURE – II AND SHALL BE OF ISI CERTIFIED/MARKED, BEST QUALITY BRANDED AND HIGH STANDARDS. DURING THE INSPECTION/TEST IF THESE ARE FOUND TO BE OF INFERIOR QUALITY AND NON-ISI MARKED MATERIAL, THE SAME ARE TO BE REPLACED BY SUPPLIER AT THEIR OWN COST WITHIN THE STIPULATED PERIOD, FAILING WHICH THE SUPPLY CONTRACT MAY BE CANCELLED. DELAYED SUPPLY/NON-COMPLIANCE OF SUPPLY ORDER MAY LEADS TO CANCELLATION OF THE CONTRACT.**
7. **While submitting the tender, if any of the prescribed conditions are not fulfilled or incomplete in any form, the tender is liable to be rejected. If any Tenderer stipulates any condition of his/her own, such conditional tender is liable to be rejected.**
8. Ambuja Foundation, reserves the right to reject any tender/bid wholly or partly without assigning any reason.
9. The Technical Committee constituted by Ambuja Foundation shall have the right to verify the particulars furnished by the bidder independently.
10. All the tender documents & Financial Bid (BoQ) are to be signed & Attached with this Tender Document.
11. **Validity:** The rates quoted shall be valid for 2 Years. The Bidders should be ready to extend the validity, if required without any additional financial implications. The decision of the Competent Authority of Ambuja Foundation will be final and binding on the suppliers.
12. No commitment by Ambuja Foundation with regard to quantity for supplying the materials/items as and when required. The quantity may get increased or decreased at the time of issuing of Supply Order in favor of the successful bidder, as per rules. Decision of the Competent Authority of Ambuja Foundation in this regard shall be final.
13. **Prices:** The base prices quoted should be inclusive of all charges like packing, forwarding, freight,

insurance, loading, unloading & transportation, at the destination site i.e., Ambuja Foundation or at the desired location as specified in the Purchase Order.

- 14. Taxes/Duties:** If taxes, duties, or any other charges over and above the rates quoted are payable by the purchaser, actual/percentage of such taxes/duties/charges should be clearly indicated.
- 15. Delivery: Time is the essence of the contract.** Hence it must be supplied at the desired location within 30 days from the date of supply order or as specified in the supply order. However, the Competent Authority will have the discretionary power to take appropriate decision.
- 16. The bidder should also provide the copies of purchase orders of similar materials supplied during last three years, if any.**
- 17. Mode of Payment:** Payment on Bill/Invoice basis subject to acceptance of the materials/items supplied in fine quality condition as per requirements & specifications stated in the Supply Order.
- 18. No advance payment by Ambuja Foundation for the items to be supplied in any circumstances.**
- 19. No minimum commitment by Ambuja Foundation for purchase of materials required during the contract period.**
- 20. Liquidated damages Security:** In case the firm does not complete the supply within the laid down agreed delivery period (including extension period in case) as per contract, liquidated damages will be charged @ 0.5% per day on the total cost of supply for delay beyond the stipulated periods subject to maximum of 5% unless extension is obtained in writing from office on valid ground before expiry of the delivery period. **Time is the essence of the contract.** However, the Institute reserves the right to either further extend or cancel the contract after expiry of delivery date.

- 21. Insurance:** It will be the responsibility of supplier to deliver the materials in good condition on FOR basis or as the case may be without involving the risk of the purchaser.
- 22. Jurisdiction:** All disputes arising out of this contract shall be subject to the jurisdiction of Indian laws & Court at Chandrapur, Maharashtra.
- 23. Supply support and material expiry date:** Comprehensive supply support from the original manufacturer/authorized supplier has to be provided for resolving any supply/quality related issues. However, the manufacturer's expiry date of material should be beyond one year from the date of supply. **Supply should be made from the latest batch of production with maximum life period in original packing.**
- 24. Performance Security:** Successful bidder will have to submit a Performance security of equivalent to 10% of the Contract/Supply Order value within the stipulated period, having validity till all contractual obligations are fulfilled by the supplier or as specified in the supply order. The same shall stand forfeited in case of cancellation of the contract for any breach of contract or for any deficiency in the performance noticed during the period of the contract/warranty.
- 25. Packing and Marking:** The packing and preservation of the supplied goods shall be airworthy/seaworthy/roadworthy (as the case may be) so that it may provide their safety during transportation.
